(1) Mr. Brooks received these 6,835 shares as part of a distribution of stock to investors by legal entities controlled by BCP Capital Management LLC of which he is a partner. BCP Capital Management LLC controls entities that distributed 1,216,565 shares of Cogent stock. This distribution brings Mr. Brooks' direct personal ownership of Cogent stock to 25,585 shares. With the distribution to investors by BCP Capital Management LLC of the 1,216,565 shares Mr. Brooks no longer needs to disclose or otherwise disclaim beneficial interest in those shares.
