As part of its initial public offering, the Issuer issued Units (the "Units"), each Unit having a price of \$10.00 and consisting of one ordinary share of Common Stock, par value \$0.0001 per share (the "Shares"), and one warrant, each warrant entitling the holder to purchase one Share at a price of \$7.50 (the "Warrants"). Each Warrant will become exercisable on the later of the completion by the Issuer of a business combination or February 14, 2009 and will expire on November 14, 2012, or earlier upon redemption. The Shares and Warrants that comprise the Units have not yet begun trading separately as of the date of this filing. Because the Issuer has not announced a business combination as of the filing date of this Schedule 13G, the shares of common stock into which the Warrants are exercisable have not been included in the number of shares beneficially owned by each Reporting Person.
