INTRODUCTION

The ownership of shares ("Shares") of Common Stock of the Issuer was previously reported by the Reporting Persons in a Schedule 13D, which was filed with the Securities and Exchange Commission on August 5, 1999, as amended by Schedule 13D Amendment No. 1, which was filed with the Securities and Exchange Commission on November 29, 1999, as amended by Schedule 13D Amendment No. 2, which was filed with the Securities and Exchange Commission on December 1, 2000, as amended by Schedule 13D

Amendment No. 3, which was filed with the Securities and Exchange Commission on October 24, 2003, as amended by Schedule 13D
Amendment No. 4, which was filed with the Securities and Exchange Commission on March 16, 2004, as amended by Schedule 13D
Amendment No. 5, which was filed with the Securities and Exchange Commission on November 24, 2004 as amended by Schedule 13D
Amendment No. 6, which was filed with the Securities and Exchange Commission on April 8, 2005, as amended by Schedule 13D
Amendment No. 7, which was filed with the Securities and Exchange Commission on April 27, 2005, as amended by Schedule 13D
Amendment No. 8, which was filed with the Securities and Exchange Commission on May 11, 2005 ("Amendment No. 8"). Since the filing of Amendment No. 8, the ownership of Shares by the Reporting Persons has changed, and the number of Shares now held by the Reporting Persons is 161,239 Shares.
