(1) The director has elected to receive a stock grant in lieu of retainer, meeting fees or other cash compensation to which he or she would otherwise be entitled. The director is not permitted to sell or transfer the underlying shares of stock received until he or she ceases to be a director of the Company.

(3) This director has elected to defer payment under the Restricted Stock Unit Deferral Program (the "Program") of the restricted stock units issued under the Circuit City Stores, Inc. 2000 Non-Employee Director Stock Incentive Plan. The shares underlying the phantom stock units in the director's account will be distributed to the director when he or she ceases to serve as director of the Company.
