Item 12. Results of Operations and Financial Condition.

On April 21, 2004, First Community Bancorp issued a press release (the "Press Release") announcing its results of operations and financial condition for the quarter ended March 31, 2004. The Press Release also announces declaration of a quarterly cash dividend of \$0.22 per common share, a 17% increase over the previous quarterly cash dividend of \$0.1875 per share.
