As a result of adoption of SFAS 123R, Share-Based Payment, effective May 1, 2006, Catalyst Semiconductor needs more time to complete its Quarterly Report on Form 10-Q ( 10-Q ) for the quarter ended July 30, 2006. Although we have dedicated significant resources to the completion of this process and have made substantial progress, there have been delays in completing the 10-Q primarily arising from the complexities of adoption of SFAS 123R. As a result, we were not able to complete and file our Form 10-Q by the prescribed filing due date without unreasonable effort and expense. We expect to be able to file our Form 10-Q on or before the fifth calendar day following the prescribed due date.
