This prospectus supplement no. 3 updates and amends certain information contained in the prospectus dated December 8, 2006, supplemented by prospectus supplement no. 1 dated December 22, 2006 and prospectus supplement no. 2 dated January 9, 2007, relating to the offer and sale from time to time by certain selling securityholders of up to \$151,800,000 aggregate principal amount of our 3½% convertible senior notes due 2011 and shares of our common stock issuable upon conversion of the notes. The terms of the notes are set forth in the prospectus. This prospectus supplement no. 3 is not complete without, and may not be utilized except in connection with, the accompanying prospectus, including any amendments or supplements thereto. This prospectus supplement no. 3 is qualified by reference to the prospectus, prospectus supplement no. 1 dated December 22, 2006 and prospectus supplement no. 2 dated January 9, 2007, except to the extent that the information in this prospectus supplement no. 3 supersedes the information contained in the prospectus, prospectus supplement no. 1, or prospectus supplement no. 2.

However, this conversion rate will be subject to adjustment as described under **Description of Notes Conversion of Notes**. As a result, the number of shares of common stock issuable upon conversion of the notes may increase or decrease in the future.

(2) Calculated based on Rule 13d-3(i), using 83,855,064 shares of common stock outstanding as of October 27, 2006. In calculating the amount for each holder, we treated as outstanding the number of shares of common stock issuable upon conversion of all of that holder's notes, but we did not assume conversion of any other notes.

RGC Management Company, LLC ( Management ) is the general partner of RG Capital. Steve Katznelson and Gerald Stahlecker serve as the managing members of Management. Each of RG Capital, Management, Katznelson and Stahlecker disclaims beneficial ownership of the securities owned by Radcliffe SPC, Ltd. for and on behalf of the Class A Segregated Portfolio.

(8) Sandelman Partners, LP has sole voting control and sole investment control over these securities. The general partner of Sandelman Partners, LP is Sandelman Partners, GP LLC. Jonathan Sandelman is the managing member of Sandelman Partners, GP LLC.
