**MTS announces subscriber growth numbers for November 2007**

**Moscow, Russian Federation Mobile TeleSystems OJSC ( MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 80.21 million users on November 30, 2007.**

During November 2007, MTS consolidated subscriber base increased by 1.09 million subscribers.

\* Significant increase in subscriber additions in October can be largely attributed to the adoption in Armenia of the churn policy used by MTS in Russia, whereby customers are defined as churning after six months of inactivity.
