MTS Announces Subscriber Growth Numbers for April 2009

Moscow, Russian Federation Mobile TeleSystems OJSC (MTS NYSE: MBT), the largest mobile phone operator in Russia and the CIS, announces that its consolidated subscriber base reached 93.03 million users on April 30, 2009.

During April, MTS consolidated subscriber base increased by 0.8 million subscribers with approximately 570 thousand subscribers added in Russia.
