(1) The undersigned is a participant in the Atlas Pipeline Partners, L.P. (the "Partnership") Long-Term Incentive Plan (the "Plan"). The undersigned received 453 phantom units under the Plan on May 10, 2004, 422 phantom units under the Plan on May 10, 2005, 363 phantom units under the Plan on May 10, 2006 and 303 phantom units under the Plan as of May 10, 2007. Each phantom unit represents the right to receive, upon vesting, either one common unit of limited partner interest of the Partnership or its then fair market value in cash; the phantom units vest 25% per year. The undersigned elected to receive common units. The units are receivable without additional consideration.

(2) The undersigned received 345 phantom units under the Plan as of May 10, 2008. Each phantom unit represents the right to receive, upon vesting, either one common unit of limited partner interest of the Partnership or its then fair market value in cash; the phantom units vest 25% per year.
