The reporting person is also a participant in the Atlas

(1) Pipeline Partners, L.P. 2010 Long Term Incentive Plant (the "2010 Plan") and received 1,862 phantom units under the 2010 Plan on March 17, 2011. Each phantom unit represents the right to receive, upon vesting, either one common unit of limited partner interest of the Partnership or its then fair market value in cash; the phantom units vest 25% per year. The reporting person elected to receive common units. The units are receivable without additional consideration.
