(5) equal to the fair market value of such shares. As noted in Footnote 3 above, units have no expiration date and are all currently redeemable for Common Shares or cash at the election of Kite.

(6) The disposition represents the surrender of common shares to fund income taxes due upon the vesting of restricted shares.
