- The reported securities are shares of common stock issued upon the vesting of restricted stock units (RSUs) based on the achievement of performance goals, plus time-based vesting requirements. This reflects corrected reporting for an RSU award originally reported on May 23, 2014. At grant, such award could have vested as to a total of 44,887 shares. Based on actual performance achieved, a total of 39,725 shares are scheduled to vest in forty-eight (48) equal monthly installments beginning on March 1, 2015.
- RSUs convert into common stock on a one-for-one basis.
 - The cumulative balance includes a reduction of 61,553 shares to reflect a correction to the reporting of the grant originally reported on May 23, 2014.
 - The reported securities were withheld to satisfy the Reporting Person's tax liability in connection with the vesting of RSUs.
