- (a) Name of Issuer: Genta Incorporated (the "Issuer").
- (b) Address of the Issuer's Principal Executive Offices: 200 Connell Drive, Berkeley Heights, NJ 07922.

- (a) Name of Person Filing: This joint statement on Schedule 13G is being filed by Peter Kolchinsky, RA Capital Management, LLC, and RA Capital Healthcare Fund, L.P., who are collectively referred to herein as the "Reporting Persons." Mr. Kolchinsky (the "Manager") is the manager of RA Capital Management, LLC ("Capital"), which is the investment adviser and sole general partner of RA Capital Healthcare Fund, L.P. ("Fund") and serves as the investment adviser to a separate discretionary account. The Reporting Persons have entered into a Joint Filing Agreement, dated as of the date hereof, a copy of which is filed with this Schedule 13G as Exhibit 1 (which is incorporated herein by reference), pursuant to which the Reporting Persons have agreed to file this statement jointly in accordance with the provisions of Rule 13d-1(k) under the Act.
- (b) Address of Principal Business Office: The principal business office of the Reporting Persons with respect to the shares reported hereunder is 20 Park Plaza, Suite 905, Boston, MA 02116.
- (c) Citizenship: Capital is a Massachusetts limited liability company. The Fund is a Delaware limited partnership. The Manager is a United States citizen.
- (d) Title and Class of Securities: Common stock ("Common Stock").
- (e) CUSIP Number: 37245M801.

Item 4. Ownership:

In the aggregate, the Reporting Persons beneficially own 42,934,982 shares of the Common Stock of the Issuer, representing approximately 9.999% of such class of securities which is comprised of 42,126,990 shares of Common Stock and the remaining shares of Common Stock which the Reporting Persons may acquire upon conversion pursuant to the terms of the Issuer's Senior Unsecured Convertible Notes due March 2013 (the "B Notes"), the Issuer's Senior Unsecured Convertible Notes due March 2013 (the "C Notes"), and the Issuer's Senior Secured Convertible Notes due March 2013 (the "D Notes"). In the aggregate the Reporting Persons own \$23,352.76 principal amount of the B Notes, \$674,160.00 principal amount of the C Notes, and \$337,080.00 principal amount of the D Notes. In addition, the Reporting Persons own \$600,000.00 principal amount of the Issuer's Warrant to purchase Senior Unsecured Convertible Notes (the "E Notes"). The B Notes, the C Notes, the D Notes, and the E Notes can only be converted to the extent that, after such conversion, the Reporting Persons would beneficially own no more than 9.999% of the Issuer's Common Stock. As a result of these restrictions, the number of shares that may be issued on conversion of the B Notes, C Notes, D Notes and the E Notes may change depending upon changes in the outstanding shares.

The beneficial ownership of each Reporting Person is as follows: (i) Fund beneficially owns 21,467,491 shares of Common Stock, representing approximately 4.999% of the class which is comprised of 21,063,495 shares of Common Stock and the remaining shares of Common Stock which the Reporting Persons may acquire upon conversion pursuant to the terms of the B Notes, C Notes and D Notes. In the aggregate the Fund own \$11,676.38 principal amount of the B Notes, \$337,080.00 principal amount of the C Notes, and \$168,540.00 principal amount of the D Notes and \$300,000.00 principal amount of the E Notes and (ii) Capital, as the investment adviser and sole general partner of the Fund and investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, and Mr. Kolchinsky as the manager of Capital, each beneficially own 42,934,982 shares of Common Stock of the Issuer, representing approximately 9.999% of the class which is comprised of 42,126,990 shares of Common Stock and the remaining shares of Common Stock which the Reporting Persons may acquire upon conversion pursuant to the terms of the B Notes, C Notes and D Notes. The percentage of Common Stock beneficially owned by each Reporting Person is based on a total of 429,392,767 shares of Common Stock of the Issuer outstanding as of September 9, 2011.

The Fund has the power to vote and dispose of the shares of Common Stock beneficially owned by such entity (as described above). Capital, as the investment adviser and sole general partner of the Fund and as the investment adviser to an account owned by a separate investment vehicle which holds shares of the Issuer's Common Stock, has the sole authority to vote and dispose of all of the shares of Common Stock reported in this Schedule 13G. The Manager, by virtue of his position as manager of Capital, has the sole authority to vote and dispose of all of the shares of Common Stock reported in this Schedule 13G.
