## **SCHEDULE TO**

This Tender Offer Statement on Schedule TO (this “Schedule TO”) is filed by CIS Acquisition Ltd., a British Virgin Islands company (the “Company”). This Schedule TO relates to the offer by the Company to all holders of the Company’s Callable Class B Ordinary Shares, par value \$0.0001 per share (the “Shares”), that will be outstanding after the closing of the Acquisition (as defined in the Offer Letter) at a price of \$10.40 per shares in cash, without interest.
