G. WILLI-FOOD PROVIDES ADDITIONAL INFORMATION
REGARDING INVESTIGATION
BY ISRAELI SECURITIES AUTHORITY

YAVNE, Israel – April 6, 2016 - G. Willi-Food International Ltd. (NASDAQ: WILC) (the “Company” or “Willi-Food”), a global company that specializes in the development, marketing and international distribution of kosher foods, today announced, further to the announcement of the Nasdaq Stock Market of February 18, 2016, that the trading of the Company's ordinary shares continues to be halted by Nasdaq until the Company has fully satisfied Nasdaq's request for additional information. Following the request the Company's auditors, the ISA was contacted to confirm whether the investigation may in any way affect the financial results of the Company for 2015 fiscal year. ISA made reference to an appendix attached to the detention petition against Mr. Gurtovoy from which it appears that the investigation concerns a particular investment made by the Company in a certain traded European bond in an alleged amount of approximately USD 3 million (of which USD 2.2 million was actually invested) and whether such investment was used as a part of the collateral granted to secure debt of the controlling shareholder of the Company or any other third party and as a result, certain disclosures and approvals were required under Israeli law.

The Company also announced that it expects to release its 20-F annual report including its financial statements on time on or about April 28, 2016.
