On October 3rd, 2006, Innospec Inc. issued a press release regarding arbitration proceedings it has issued against Ethyl Corporation, a subsidiary of NewMarket Corporation. These arbitrations arise out of disputes Innospec has with Ethyl under the companies' marketing and supply agreements for tetra ethyl lead (TEL). Under these actions, Innospec is claiming damages and the right to terminate the agreements.

Under a separate agreement, whereby Innospec supplies Ethyl with TEL for re-sale in the US, Innospec is disputing the price it is entitled to charge for the supply of TEL.
