- (1) Pursuant to the terms of a Founders Option Agreement, dated as of October 12, 2007, by and among Great Point Partners, LLC ("Great Point"), Sean McDevitt, Pat LaVecchia, John Voris, Wayne Yetter and Jean Pierre Millon, Pat LaVecchia granted to Great Point an option (the "Option") to purchase 159,575 shares of common stock, par value \$0.0001 per share of HAPC, INC. ("HAPC") to be issued to Mr. LaVecchia by HAPC upon the closing of the transactions contemplated by the Stock Purchase Agreement, dated as of September 29, 2006, by and among HAPC, Iceland Acquisition Subsidiary, Inc., InfuSystem, Inc. and I-Flow Corporation (the "Stock Purchase Agreement"). The Option becomes exercisable upon the closing of the transactions contemplated by the Stock Purchase Agreement.
