- (1) Grant of 10,000 deferred stock units (DSUs) under the Issuers 2004 Equity Incentive Plan. Each DSU represents a right to receive one share of Indevus common stock. The grant vests in three equal annual installments on March 11, 2009, 2010, and 2011. Upon the earlier of the recipient's retirement from the Board of Directors of the Issuer or five years from the date of grant, any DSUs that are vested and have not been terminated are converted into common stock and distributed to the recipient, unless further deferred by the recipient.
