(1) Mr. Young contributed the 1,851 shares purchased in this transaction, along with 833 shares of directly held previously restricted stock issued under the company's Non-Employee Director Restricted Stock Plan to the Young 1999 Family Limited Liability Partnership. In addition, 2,571 shares of directly held common shares were incorrectly reported as part of Mr. Young's indirect holdings. This will lower indirect holdings shown in future filings by 2,571 shares.

(2) Mr. Young contributed 833 shares of directly held previously restricted stock issued under the company's Non-Employee Director Restricted Stock Plan to the Young 1999 Family Limited Liability Partnership. This will lower direct holdings shown in future filings by 833 shares.
