(1) The securities awarded on July 15, 2010 are in the form of restricted stock units (RSUs) issued pursuant to the SeaChange International, Inc. Amended and Restated 2005 Equity Compensation and Incentive Plan that entitle the reporting person to receive one (1) share of common stock per RSU. The RSUs will vest, and the underlying common stock will issue, ratably over three years. The first tranche will vest on July 15, 2011, with an equal number of shares vesting on July 15, 2012 and the balance of the shares vesting on July 15, 2013.
