On July 17, 2013, Spirit Realty Capital, Inc. ("Predecessor"), merged with and into Cole Credit property Trust II, Inc. ("Issuer"), renamed (1) Spirit Realty Capital, Inc. following the consummation of the merger. In connection with the merger, each share of Predecessor's common stock was converted into the right to receive 1.9048 shares of Issuer's common stock.

Includes (i) 95,240 shares of restricted stock that shall vest in three equal installments on the first, second and third anniversaries of (2) September 25, 2012, and (ii) 18,569 shares of restricted stock that shall vest in three equal installments on each of January 1, 2014, January 1, 2015 and January 1, 2016.
