Each phantom unit represents the right to receive, upon vesting, either one common unit of limited partner interest of the Partnership or its then fair market value in cash. The phantom units vest 25% per year. The reporting person elected to receive common units for the vestings that occurred on March 17, 2014. The units are receivable without additional consideration.
