On March 4, 2008, the reporting person transferred funds held in the Directors Predecessor Account (Prime Rate Fund) in his deferred compensation account into the Directors Retirement Account (phantom stock) in his deferred compensation account pursuant to the Cleco Corporation Deferred Compensation Plan (the "Plan"). Shares of phantom stock may be transferred by the reporting person into an alternative investment account in the Plan at any time pursuant to the terms and provisions of the Plan.
