Unilever NV announces that on 12 October 2005, it purchased 90,927 Unilever NV ordinary shares (in the form of depositary receipts thereof) at prices between EUR58.20 and EUR58.65 per share. The purchased shares will be held as treasury shares.

Unilever NV also announces that 2,125 Unilever NV ordinary shares held as treasury shares were released under Employee Share Plans.

Following the above purchase and release, Unilever NV together with subsidiary companies, holds 20,395,563 Unilever NV ordinary shares in treasury, and has 551,180,337 Unilever NV ordinary shares in issue (excluding treasury shares).

Unilever PLC announces that on 12 October 2005, it purchased 420,000 Unilever PLC ordinary shares at prices between 582.00 pence and 586.00 pence per share. The purchased shares will be held as treasury shares.

Following the above purchase, Unilever PLC holds 3,243,677 Unilever PLC ordinary shares in treasury, and has 2,908,214,903 Unilever PLC ordinary shares in issue (excluding treasury shares).
