**(b) Retirement of President and Chief Executive Officer.**

On February 19, 2008, James R. Martin, President and Chief Executive Officer of MVB Financial Corp. ( MVB ) and President and Chief Executive Officer of MVB 's wholly-owned subsidiary, MVB Bank, Inc.
