On March 31, 2008, OMNI Energy Service Corp. (the Company) issued a press release announcing a decision from the 15th Judicial District Court in Lafayette, Louisiana, as a result of a jury verdict, rejecting the defense claims of the Company's wholly-owned subsidiary, Preheat, Inc. (Preheat), in respect of claims asserted by Siemens Water Technologies Corporation (Siemens). The claims related to Preheat's alleged improper use of trade secret information belonging to Siemens and the subsequent alleged engagement in unfair trade practices and unfair competition with respect to Siemens.
