**ITEM 3.02. Unregistered Sales of Equity Securities; Other Events**

On December 22, 2009, Zions Bancorporation ( Zions ) issued a press release announcing the preliminary results of its offer to exchange shares of its common stock, without par value (the Common Stock ), for any and all of its depositary shares (the Depository Shares ) each representing a 1/40th interest in a share of Series A Floating-Rate Non-Cumulative Preferred Stock (the Series A Preferred Stock ) with a liquidation preference of \$25.00 per Depository Share (equivalent to \$1,000 per share of Series A Preferred Stock), upon the terms and subject to the conditions described in the Offer to Exchange, dated November 23, 2009, as amended and supplemented by Amendment No. 1 filed on December 3, 2009 and by Amendment No. 2 filed on December 18, 2009, and in the related Letter of Transmittal (the Exchange Offer ). The Exchange Offer expired at 11:59 p.m., New York City time, on December 21, 2009. The final results of the Exchange Offer were unchanged from those reported in the press release.

On December 22, 2009, Zions also completed the settlement of the Exchange Offer. In the aggregate, Zions issued 2,816,834 shares of Common Stock (approximately 1.96% of Zions outstanding Common Stock, based on the number of shares outstanding as of November 30, 2009) in exchange for 2,861,493 Depository Shares. Overall, approximately \$71.5 million liquidation amount of Zions Depository Shares were validly tendered, not withdrawn and exchanged upon the terms and subject to the conditions set forth in the Exchange Offer, which represented 51.29% of the aggregate liquidation amount of its Depository Shares outstanding prior to the settlement of the Exchange Offer. The shares of Series A Preferred Stock represented by the Depository Shares received in the Exchange Offer were retired upon receipt. After settlement of the Exchange Offer, 2,718,072 Depository Shares, representing 67,951.8 shares of Series A Preferred Stock, remained outstanding.

The Common Stock was issued in the Exchange Offer in reliance upon the exemption set forth in Section 3(a)(9) of the Securities Act of 1933, as amended, for securities exchanged by an issuer with its existing security holders exclusively where no commission or other remuneration is paid or given directly or indirectly for soliciting such exchange.
