The filing deadline for the Annual Report on Form 10-K for the year ended December 31, 2011 (the Form 10-K) of Flagstar Bancorp, Inc. (the Company) is March 15, 2012. During the course of reviewing its financial statements, the Company submitted a preclearance request to the Office of Chief Accountant of the Securities and Exchange Commission relative to the accounting treatment of the Company s settlement with the United States Department of Justice. The Company has been in continuous dialogue with the SEC on this matter. The SEC has confirmed that it does not object to the use of the fair value option to measure the Additional Payments, as defined, which the Company must make to the DOJ. The SEC is currently reviewing the valuation of that financial liability arising from the obligation to make the Additional Payments. The Company expects to receive resolution shortly, following which the Company expects to finalize and file its Form 10-K with the SEC on or before the March 30, 2012 extended due date.
