DTE Energy Company ( DTE Energy ) President and Chief Executive Officer Gerard M. In the business update presentation, DTE Energy reaffirms its 2012 operating earnings per share guidance of \$3.65-\$3.95 per share.

Reconciliations to the comparable 2012 reported earnings guidance are not provided because it is not possible to provide a reliable forecast of specific line items. These items may fluctuate significantly from period to period and may have a significant impact on reported earnings.
