Each ADS represents one Share. Pursuant to Rule 416 under the U.S. Securities Act of 1933, as amended (the Securities Act), this Registration Statement on Form S-8 shall also cover any additional Shares that become deliverable by reason of any stock dividend, stock split, recapitalization or other similar transaction effected without the receipt of consideration that results in an increase in the number of outstanding Shares to be offered or sold pursuant to the plans.
- (2) Represents an aggregate of 20,205,000 Shares, of which 9,000,000 Shares are available for future issuance under the Nokia Performance Share Plan 2013, 710,000 Shares are available for future issuance under the Nokia Performance Share Plan 2012, 1,590,000 Shares are available for future issuance under the Nokia Performance Share Plan 2011, 4,500,000 Shares are available for future issuance under the Nokia Restricted Share Plan 2013, 3,500,000 Shares are available for future issuance under the Nokia Stock Option Plan 2011, and 905,000 shares are available for issuance pursuant to the Nokia Employee Share Purchase Plan.
