On February 14, 2014, Mr. Choi, Gyo-II, Mr. Lee, Kang-Hee and Mr. Cho, Jeon-Hyeok were appointed as non-standing directors and members of the board of directors of Korea Electric Power Corporation ( KEPCO ) by the Minister of the Ministry of Strategy and Finance. The term of office for each of these three directors is for two years and will terminate on February 13, 2016. Following the appointment of these directors, KEPCO will have a total of eight non-standing directors, which comprise a majority of the 15-member board of directors.
