**Item 1.01 Entry into a Material Definitive Agreement**

On April 23, 2014, in connection with the closing of the initial public offering (the *Offering*) by Sabre Corporation (the *Company*) of its common stock, the Amended and Restated Registration Rights Agreement, dated as of April 23, 2014 (the *Registration Rights Agreement*), was entered into by and among the Company, TPG Partners IV, L.P., TPG Partners V, L.P., TPG FOF V-A, L.P., TPG FOF V-B, L.P., Silver Lake Partners II, L.P., Silver Lake Technology Investors II, L.P. and Sovereign Co-Invest, LLC (collectively, the *Sponsors*) substantially in the form previously filed as Exhibit 4.8 to the Company's Registration Statement on Form S-1 (File No. 333-193438), as amended (the *Registration Statement*). Additionally, in connection with closing of the Offering, the Income Tax Receivable Agreement, dated as of April 23, 2014 (the *Tax Receivable Agreement*), was entered into between the Company and Sovereign Manager Co-Invest, LLC, as representative of the Existing Stockholders (as defined in the Tax Receivable Agreement) substantially in the form previously filed as Exhibit 10.44 to the Company's Registration Statement. Finally, in connection with closing of the Offering, the Amended and Restated Stockholders Agreement, dated as of April 23, 2014 (the *Stockholders Agreement*), was entered into by and among the Company and the Sponsors substantially in the form previously filed as Exhibit 10.45 to the Company's Registration Statement. Copies of the Registration Rights Agreement, Tax Receivable Agreement and Stockholders Agreement are filed as Exhibits 4.1, 10.1 and 10.2, respectively, herewith and incorporated by reference herein.
