**ChipMOS REPORTS NOVEMBER 2015 REVENUE**

**Hsinchu, December 10, 2015** - ChipMOS TECHNOLOGIES (Bermuda) LTD. ( ChipMOS or the Company ) (NASDAQ: IMOS), an industry leading provider of outsourced semiconductor assembly and test services ( OSAT ), today reported its unaudited consolidated revenue for the month of November 2015.

Revenue for the month of November 2015 was NT\$1,576.7 million or US\$48.5 million, a decrease of 1.7% from the month of October 2015 and a decrease of 19.1% from the same period in 2014. All U.S. figures in this release are based on the exchange rate of NT\$32.53 to US\$1.00 as of November 30, 2015.
