Rio de Janeiro, September 22, 2017 **Petróleo Brasileiro S.A.** Petrobras reports that it has initiated the opportunity disclosure stage (Teasers) related to the full sale of its exploration, development and production rights in five sets of onshore fields (totaling 19 concessions), located in Ceará, Rio Grande do Norte and Sergipe states, as per the table below.

Petrobras share in the average oil and natural gas production in those fields in the year 2016 was 17.4 thousand barrels of oil equivalent per day.

Petrobras is the operator in all concessions with 100% stake, except for Sanhaçu field, where the company is the operator and holds 50% and Petrogal holds the remaining 50%.
