**Item 1.01 Entry into a Material Definitive Agreement.**

On June 4, 2018, Invesco Specialized Products, LLC, as Sponsor of the CurrencyShares® Euro Trust (the Trust ), entered into a Global Amendment to Depositary Trust Agreements with The Bank of New York Mellon, in its capacity as Trustee of the Trust and eight other trusts (the Global Amendment ). The Global Amendment changed the name of the Trust, effective that same day, to Invesco CurrencyShare® Euro Trust as approved and directed by the Sponsor on behalf of the Trust.

The name change does not affect the rights of the holders of Euro Shares (the Shares ). No other changes to the Depositary Trust Agreement dated December 2, 2005, establishing the Trust, were made in connection with the name change.

The Shares continue to trade on NYSE Arca under the symbol FXE. Along with the name change, the Shares have been assigned a new CUSIP number, which is 46138K103.

A copy of the Global Amendment effecting the name change is attached hereto as Exhibit 4.1.
