These derivative securities are currently redeemable. The Units have no expiration date.
- (2) This transaction involved an annuity distribution of 7,999 Units from a Grantor Retained Annuity Trust ("GRAT") for the benefit of the reporting person's spouse to the reporting person's spouse. The reporting person serves as the trustee of the GRAT.
- (3) The Units are held by the GRAT for the benefit of the reporting person's spouse.
- (4) The reporting person disclaims beneficial ownership of the shares held by his spouse, and this report should not be deemed to be an admission that the reporting person is the beneficial owner of his spouse's shares for purposes of Section 16 of the Securities Exchange Act of 1934, as amended, or for any other purpose.
