- (1) (1) Includes 8,000 shares of common stock with respect to the exercise of options, the delivery of which has been deferred
- (2) The options vest over an eight (8) year period in relatively equal amounts at various vesting intervals. The initial exercise price is \$8.98. The exercise price can be reduced and the vesting schedule can be accelerated by the Optionee purchasing and maintaining ownership of shares of the Company's common stock and/or the Company achieving performance objectives as determined by the Board. Based upon the maximum required ownership of common stock as provided in the Stock Option Agreement together with the Company achieving the performance targets previously established by the Board, the option can fully vest after approximately fifty-four (54) months and the exercise price can be reduced to the par value of the Company's common stock, or \$.01 per share
