- (1) Restricted stock granted under the Centex Corporation 2003 Equity Incentive Plan. The 5/11/06 Award vests at the rate of 33 1/3% per year on each of March 31, 2007, March 31, 2008, and March 31, 2009.  
This amount represents an award of units under the Long Term Incentive Plan. Each LTIP unit represents the right to receive one share of Centex common stock at the time the award is paid. The 5/14/04 award vests at the rate of 8.25% per quarter in fiscal 2005, 8.25% per quarter in 2006 and 8.50% per quarter in 2007. The 5/12/05 award vests at the rate of 8.25% per quarter in fiscal 2006, 8.25% in fiscal 2007 and 8.50% in fiscal 2008. (Centex's fiscal year begins on April 1 and ends on March 31.)
  - (2) Centex common stock at the time the award is paid. The 5/14/04 award vests at the rate of 8.25% per quarter in fiscal 2005, 8.25% per quarter in 2006 and 8.50% per quarter in 2007. The 5/12/05 award vests at the rate of 8.25% per quarter in fiscal 2006, 8.25% in fiscal 2007 and 8.50% in fiscal 2008. (Centex's fiscal year begins on April 1 and ends on March 31.)
  - (3) Stock options granted under the Centex Corporation 2001 Stock Option Plan. The 5/11/06 Award vests at the rate of 33 1/3% per year on each of March 31, 2007, March 31, 2008, and March 31, 2009.
