- (1) The Series A Convertible Preferred Stock is convertible into the common stock of Argyle Security, Inc. at a price per share determined by dividing the original issue price of the Series A Convertible Preferred Stock (\$800) by the conversion price for the Series A Convertible Preferred Stock (\$8).

- (2) Subject to adjustment for certain anti-dilution protection, includes 713,300 shares of common stock issuable upon conversion of additional shares of Series A Convertible Preferred Stock and 2,727,300 shares of common stock issuable upon conversion of Series B Convertible Preferred Stock. The shares of common stock are beneficially owned by the reporting persons through a "group" for purposes of Section 13D of the Exchange Act. The group is composed of the following entities and individuals: Fund IV, Coinvest, and Mezzanine. Fund IV shares voting and dispositive power over 5,300,100 of the shares. Coinvest A shares voting and dispositive power over 69,700 of the shares. Mezzanine has voting and dispositive power over all 5,369,800 shares.

- (3) The Series A Convertible Preferred Stock has no expiration date.
