- (1) Restricted shares granted pursuant to the Invacare Corporation 2003 Performance Plan in an exempt transaction under Rule 16b-3. These shares vest in 25% increments over four years commencing May 15, 2014.

- (3) The reporting person holds previously reported options to buy 22,691 Common Shares (with tandem tax withholding rights) under the Invacare Corporation 2003 Performance Plan, granted in reliance upon the exemption provided by Rule 16b-3. All options were granted between December 15, 2003 and December 22, 2010, at exercise prices between \$10.695 to \$47.01 per share, will expire between December 15, 2013 and August 20, 2018 and became or will become exercisable between December 31, 2004 and January 1, 2014.
