On February 25, 2014, Mr. Jandro was granted a performance-based RSU award at target for 27,079 shares of common stock, subject to the achievement of certain performance criteria. One-third of the shares are eligible to vest in each performance period up to a maximum of 150% of target. The performance criteria related to these shares were met at 150% of target for the second performance period, as determined by the administrator per the terms of the original grant, and the common stock issuable with respect to these 13,539 performance-based RSUs will vest on February 5, 2016, subject to Mr. Jandro's continuous status as a service provider through such date.

On February 24, 2015, Mr. Jandro was granted a performance-based RSU award at target for 11,270 shares of common stock, subject to the achievement of certain performance criteria. One-third of the shares are eligible to vest in each performance period up to a maximum of 150% of target. The performance criteria related to these shares were met at 150% of target for the first performance period, as determined by the administrator per the terms of the original grant, and the common stock issuable with respect to these 5,635 performance-based RSUs will vest on February 5, 2016, subject to Mr. Jandro's continuous status as a service provider through such date.
