- (1) This amendment corrects the amount beneficially owned. Includes 6,500 shares not reported previously due to administrative error. Represents a "net exercise" of outstanding stock options. The reporting person received 6,638 shares of common stock on the net exercise of an option to purchase 19,500 shares of common stock. The reporting person forfeited 12,862 shares of common stock underlying the option in payment of the exercise price, based on the market price of CEVA common stock at the time of the option exercise on May 4, 2016 of \$26.16.
- (3) The stock option becomes exercisable as to 25% of the underlying shares on the first year anniversary of the grant date and 25% each year thereafter.
