- (1) Each Restricted Stock Unit ("RSU") represents a contingent right to receive at settlement one share of Invensense common stock at no cost.
- (2) The sale reported in this Form 4 was effected pursuant to a Rule 10b5-1 Sales Plan adopted by the reporting person on June 17, 2016. The price reported in Column 4 reflects the weighted average price. These shares were sold in multiple transactions at prices ranging from \$8.11 to \$8.26, inclusive.
