Restricted stock unit (RSU) award designed to retain critical talent through completion of Plant Vogtle Units 3 and 4 in accordance with the schedule approved by the Georgia Public Service Commission in December 2017. The RSU award will vest 20% each year for five (1) years, on December 31 of each year, beginning December 31, 2018. Vesting will be accelerated if the fuel load authorization for Unit 3 and Unit 4 is received from U.S. Nuclear Regulatory Commission before December 31, 2022. Additional units will be acquired with deemed dividends. Shares will be withheld upon vesting to satisfy tax requirements.
