The reporting person also indirectly beneficially owns 7,756 shares through the ADC Telecommunications, Inc. Retirement Savings Plan (401k). The reporting persons holdings through the ADC Telecommunications, Inc. Retirement Savings Plan (401k) had previously been reported as 42,346 shares, but have been adjusted to reflect the reverse stock split on May 10, 2005. The information herein is based on a plan statement dated as of 6/30/05.
