Dr. Armen is also the CEO, the Chairman of the Board of Managers, and a member of Antigenics Holdings LLC ("Holdings") which as of the date of this report, owns 11,154,274 shares of Antigenics Inc. common stock. Dr. Armen has a pecuniary interest in only a portion of the shares held by Holdings and disclaims their beneficial ownership except to the extent of his pecuniary interest therein.
