(BM&FBOVESPA: BRKM3, BRKM5 and BRKM6; NYSE: BAK; LATIBEX: XBRK) hereby informs the market that the risk rating agency Fitch Ratings (Fitch) reaffirmed the Company's investment grade rating on a global scale ("BBB-"), despite the downgrade given to the Brazil's sovereign.

In this context, Braskem's investment grade rating is maintained by the three risk rating agencies, Fitch, Standard & Poor's and Moody's, being classified above the Brazil's sovereign risk by both Fitch and Standard & Poor's.
