- (1) Includes 11 shares acquired through the reinvestment of dividends on September 30, 2004, at prices of \$56.078-\$56.3182 per share.  
The number of underlying securities is based on the stock fund balance on November 17, 2004. The actual number of shares issuable upon the distribution date is not determinable since the stock fund is a unitized account consisting of 96% company stock and 4% money market fund. The stock account balance reflected in this report is based on the November 17, 2004 stock fund price of \$61.81 per share.
- (3) The phantom stock units convert to the common stock's cash value on a one-for-one basis.
- (4) The phantom stock units were accrued under the Johnson Controls Executive Incentive Compensation Plan and are to be settled 100% in cash upon the reporting person's retirement.
- (5) Includes 16.476 phantom stock units acquired through the reinvestment of dividends on September 30, 2004, at a price of \$56.81 per phantom unit.
- (6) The phantom stock units were accrued under the Johnson Controls Long-Term Performance Plan and are to be settled 100% in cash upon the reporting person's retirement.
- (7) Includes 3.709 phantom stock units acquired through the reinvestment of dividends on September 30, 2004, at a price of \$56.81 per phantom unit.
- (8) The restricted stock units were accrued under the Johnson Controls Restricted Stock Plan. The units represent the reinvestment of dividends and are to be settled 100% in cash upon the vesting of the reporting person's Restricted Stock.
- (9) Includes 48.148 phantom stock units acquired through the reinvestment of dividends on September 30, 2004, at a price of \$56.81 per phantom unit.
