Effective December 31, 2006, James A. Henderson and W. Craig McClelland retired from the Board of Directors of International Paper Company (the "Company") in compliance with the Company's mandatory retirement age policy for directors.

Item 8.01. Other Events.

Robert M. Amen entered into a retirement agreement (the "Agreement") with the Company as of March 21, 2006 pursuant to which Mr. Amen retired as president of the Company on March 31, 2006. A redacted version of the Agreement was filed with the Securities and Exchange Commission (the "Commission") as Exhibit 10.1 to the Company's Form 10-Q for the three months ended March 31, 2006, which was filed with the Commission on May 9, 2006. The Company simultaneously requested from the Commission the confidential treatment of certain commercial information contained in the Agreement pursuant to Rule 24b-2 of the Securities Exchange Act of 1934 (the "Request"). On January 5, 2007, the Company withdrew the Request from consideration by the Commission. The unredacted Agreement is filed herewith as Exhibit 10.1.
